Privacy policy

Our commitment to your privacy

Westburg BV is committed to respecting and protecting your privacy in accordance with the EU General Data Protection Regulation (GDPR). In this privacy statement we explain how and why we process personal information and what purpose we want to achieve with this processing. This privacy statement applies to:

- Natural and legal persons purchasing or using our products and services.
- Parties from which we purchase goods and / or services.
- Visitors to our website.
- Participants of one of our surveys.
- Persons with whom Westburg shares information via social media, newsletters or email.

Collection of Website Visit Information from All Visitors

When browsing our website, "cookies" (small text files temporarily or permanently stored on your computer's hard drive) will be placed on your PC during your visit to collect information related to your visit.

For each visitor to our website, we automatically collect anonymized data. This data is stored in secure log files on servers hosted by Google, Salesforce.com, Mouseflow.com, and Kirra and used to improve the quality and effectiveness of our website for our visitors.

Using these different types of cookies, Westburg collects information for internal purposes only and none of the collected information is shared with or sold to third parties.

The section 'Cookies' will give you more information regarding the cookies we use.

Cookies

During your visit to our website, we may place different types of cookies. For some cookies that Westburg uses, you must give prior consent, according to Dutch law. Below you will find which cookies are involved. If you prefer not to accept cookies, you may change the default setting and configure the browser to refuse cookies. However, this may limit your use of our website as some features, displays and services do not function properly without using cookies.

Functional cookies have a technical functionality for proper website function. Your prior consent is not necessary for the use of these cookies.

Collection of personal information

Personal information is collected by Westburg, only when you specifically and knowingly choose to provide it to us, which can be used by us for business purposes and to better serve you as a customer or as a user of our website. Personal information that we may process:

- gender
- role in your organization

 product updates, marketing, and support materials, participate in reward or promotion
 programs and surveys educational background and employment history and job interest data
 when applying for a job.
- any information that you actively send to Westburg in electronic or printed form.
- information received from our business partners and other third parties provided that such third parties have obtained your consent to the use of your personal information.
- publicly available information about you may be collected by us if needed for business purposes, and to better serve you as our customer

If any third party provides information about you to us, we may collect and process such information with other information we have about you in the public domain. This Policy will cover such processed information.

Protection of personal information

We follow generally accepted industry standards to protect the personally identifiable information submitted to us, both during transmission and once we receive it. We strive to ensure that personal information that we process is accurate. We will not process more personal information than is necessary. Personal information will not be stored by Westburg longer than is necessary for the purposes for which it was collected or further processed. For the different processing of personal information, an appropriate retention period has been determined by Westburg. To protect your personal information, we have taken the following measures:

- The servers that store your personal information are hosted by Microsoft, Google, Salesforce.com and Kirra. Both these servers and devices of employees that make use of the data are equipped with current security software, such as a virus scanner and firewall.
- We only send your information via secure internet connections (TLS, formerly SSL). You can see this at the address bar 'https' and the padlock.

Sharing with third parties

We will not sell, rent or lease your personally identifiable information you provide to us to external parties without your permission, except where required by law or governmental or judicial bodies with proper authority.

We may share information about you with our suppliers when circumstances arise that call for this disclosure. This may include problem solving, product recall and continuation of your business relationship with the supplier as a current or past user of a product manufactured by this supplier. Our suppliers will be required to treat the information in accordance with this policy or otherwise with your further permission.

We may also disclose information provided by you in connection with corporate restructuring, sale or assignment of substantial assets, merger, acquisition, and other changes of control or financial status. If such circumstances arise, we will require the recipient to use the information in accordance with this policy.

Choices for personal data

We offer all customers and website visitors the opportunity to view, change or delete all personal information that is currently provided to us.

You can email a request for access, change, transfer or deletion of your personal data, or any other question or request related to that data to info@westburg.eu.

You also have the possibility to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
